

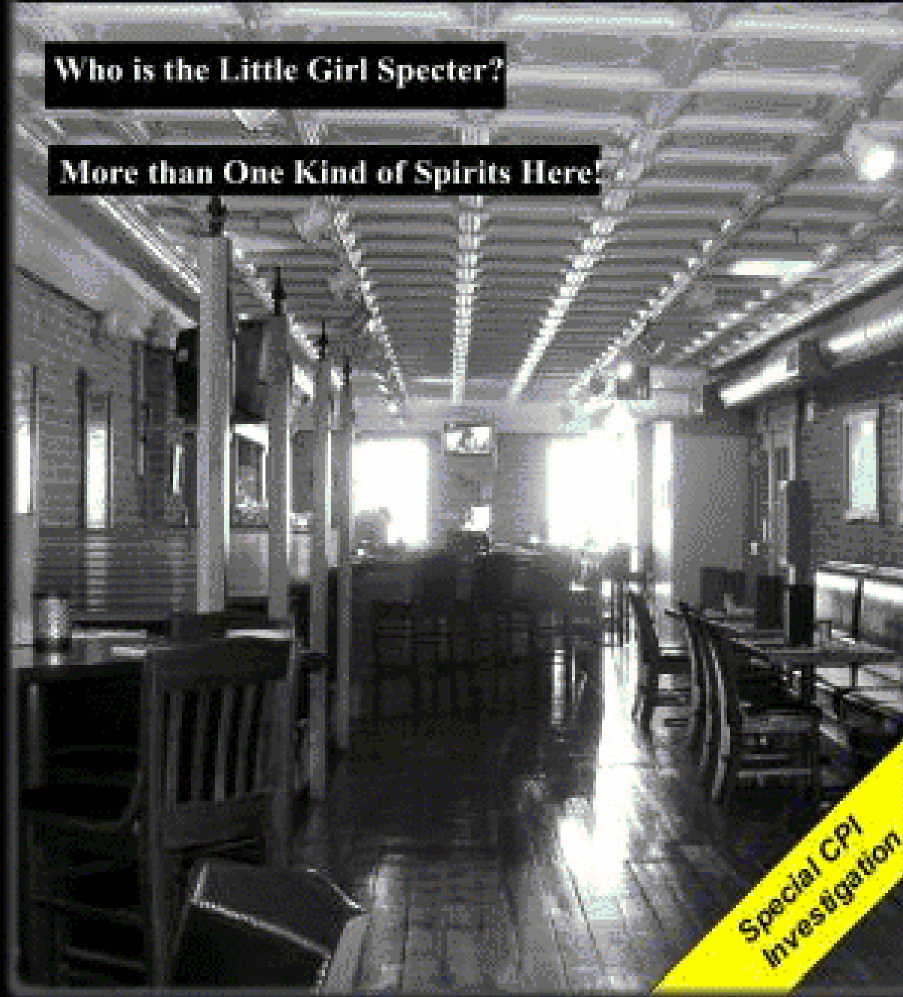

HoBo data logger

EMF Tri-field meter

Temperature gauge

Ovilus Model I

Non Paranormal Equipment:

Alphabet letters on a magnetic board

A ball that was left upstairs

Client Report:

Preliminary Investigation:

A preliminary investigation was not scheduled since Carol and Kathy assisted another paranormal group in an investigation at the restaurant.

Investigation:

Quad system was setup, 3rd floor: in main room: one camera facing wall, one camera facing rear of building and one facing the front, entrance to the 3rd floor. Landing going up to 3rd floor was videoed with a fourth camera.

Base readings, including temperature and emf levels were noted, nothing abnormal was documented. EMF - Min: 0.0 – Max 2.2 – During initial sweep - Average EMF Base Reading is: 1.1

Temp –Min 62.8 – Max 67.2 – Average med temp is: 65.2

Evp session's were done in all areas of the 3 levels that were investigated. Nothing is recognizable as an evp on any of the recordings. One note of interest, while conducting an evp session in the main dining area on the first floor a question was asked if a noise would be made if someone was with us. A loud noise was captured on Carol's camcorder that came from the back room by the swinging doors and all investigators audibly heard the noise. Upon investigating the area, nothing was noted as being out of place, there weren't any additional noises captured.

Digital pictures were taken, nothing was noted in any still pictures.

Personal Experiences

There were a few noted incidences that were noted please see below for them written in the investigators words:

Mary: End of night for me (but all rest staying and heading down to 1st floor to investigate). Eric accompanied me up to the 3rd floor to retrieve my stuff because I was leaving. I was still running and recording on my emf/Mel. As I entered the room to the right where my stuff was on the floor next to the center wall, I was telling Eric I was going to grab my stuff and head out now. Suddenly I got the largest emf spike of the evening on that floor and a first in that area thus far and the longest lasting one – 4.1. During that 4.1 spike the temperature was 74 (the highest of of the evening.)

Walt; unfortunately didn't have any personal experience, also nothing was noted on the HoBo logger.

Carol: during the investigation on the third floor I felt a cold area and called for Kathy to come over to the area to see if she felt it also. This was the area in Pictures #1 and #2 attached to this report. She also felt it and asked Walt to go get an EMF detector to use it in the area. But before Walt could return the feeling in the area dissipated.

Kathy: when Carol called me to the area listed above while I was standing there I felt something tug on my pants leg, I check to make sure the pant hem was not stuck on the floor or possibly my shoe, nothing of a natural cause could be found to explain this.

Conclusion:

Even though there wasn't any noted scientific evidence it is the opinion of CPI that there is some paranormal activity and would encourage another investigation/s.
